There is one item that needs your attention, and it concerns the 2006 Spring Meeting of South Central Classis at Providence Reformed Church, Rock Springs, WY.

In light of the fact that there are going to be two licensure examinations, which will most likely extend Classis at least one day, the executive committee thought it would be good if Classis convened a day early, on Monday March 27, instead of on Tuesday, March 28, thus suspending Standing Rule #22, that Classis convene on the 4<sup>th</sup> Tuesday of March. ## Grace Reformed Church of Greeley, CO

On November 3<sup>rd</sup>, 2005, Home Missions Chairman Ron Morris was able to meet with the consistory of Grace Reformed Church of Greeley at their building in Colorado. Rev. Gene Sawtelle reported that the congregation in Greeley currently has 36 communicant members and 17 non-communicant members. Two members are in confirmation, with 5 in catechism. Greelev was recently reported as the fastest growing city in the US. It is a bedroom community for Denver and Ft. Collins with an abundance of less expensive housing. However, there have been many costly layoffs. It is said to have the lowest per capita income for the general area. There are big housing projects to provide housing for the Denver jobs but no new payroll jobs in the city of Greeley. Greeley is about 50 miles from Denver and has about 80,000 citizens. Greeley is also a college town and there is potential for a student ministry there. Because of the particular situation of Greeley's economy, there is also a high Hispanic population with a potential for ministry among Hispanic peoples. The Greeley work has been blessed with good buildings. Currently, they owe abut \$151,000 on the church building and the parsonage. They are working on making the facility more handicapped accessible. Currently they publish their presence in the Greeley Tribune with an ad that includes the sermon title, text and other information. They currently have 4 elders and 2 deacons. Rev. Sawtelle has decided to retire from the ministry at the end of May so they will need a new minister. May God provide for this vital work in northern Colorado. They are requesting \$13,586 from Synod and Classis which is a 10% reduction from last year's request.

#### High Plains Reformed Church of Calhan, CO

On February 8, 2006, Classis Home Missions Chairman Ron Morris had a conference call with the consistory of High Plains Reformed Church of Calhan, CO. Elder Sam Powell and the consistory reported that they have an average attendance of about 50 - 55 on a Sunday morning. They currently have 52 baptized members: 36 communicant and 16 unconfirmed children. They have a 9:00 am Sunday School and 10 am Sunday morning worship. They also have a Sunday evening Bible study. They had 8 youth confirmed last year and 1 person join by profession of faith. They have a few more families visiting and expressing an interest in joining. Calhan is more and more transitioning from a rural town to a bed-room community for Colorado Springs. Many families have at least one spouse traveling into the Springs for work. As far as their buildings go, they have paid off their loan for the parsonage that they received from Synod. They have about \$118,000 in debt remaining on the parsonage which averages out to be about \$1042.86/month. The parsonage is worth an estimated \$165,000. The actual church building is a former Lutheran building which they own debt free. They have done some cosmetic work on the church building which consists of painting and landscaping, sheet rocking and texturing. The old building has been completely remodeled and rewired. There are some issues facing this congregation. The consistory believes that the problems have been identified and they are working on them. Because they are unsure about the problems that they have, they have

asked to not take a reduction in funding for 2007. They are requesting the same amount which is \$14,400 each from Classis and Synod.

#### Providence Reformed Church of Vermillion, SD

On February 10, 2006, Home Missions Chairman Ron Morris was able to meet in Vermillion with Rev. Robert Grossmann and Elder Dan Van Persum. They reported that things are going well in Vermillion. The congregation is faithful in attendance and are spiritually in good health. This last year they confirmed five covenant youth. They also had two adult baptisms and one profession of faith. The Vermillion congregation currently has 23 communicant members and 31 baptized members. An encouraging sign is the fact that they have two Chinese students from the local college, the University of South Dakota, as regular attenders. The facilities there are quite nice and are paid for. The parsonage is large and right next to the church building. The church building is very nice and was given to the RCUS from the CRC. The local congregation has made many improvements on the facilities. They installed a new sprinkler system for the church lawn and hope to re-shingle the parsonage this year. Rev. Grossmann does a weekly radio program on an AM station that broadcasts to a 5 state region. They have had some positive feedback from these broadcasts. They are requesting a 10% reduction in funding for 2007 which is \$8720 from both Classis and Synod.

# **REPORTS OF OFFICERS President's Report on the State of the Church**

In the Apostle Paul's concluding remarks in his first epistle to the Corinthians he writes, "But I will tarry in Ephesus until Pentecost. 9 For a great and effective door has opened to me, and there are many adversaries" (1 Cor. 16:8-9). It is interesting to see how Paul views his stay in Ephesus. We know from Acts 19 that when he arrived there a huge riot broke out among the local silversmiths who protested Paul's presence and his message. When they heard what Paul was teaching "they were full of wrath and cried out, saying, 'Great is Diana of the Ephesians!' So the whole city was filled with confusion, and rushed into the theater with one accord." Yet when Paul is describing his stay in Ephesus to the Corinthians he acknowledges that there are many adversaries but at the same time says that a great and effective door had been opened for the gospel. What an interesting way to view problems in the ministry. Paul viewed his problems as an opportunity to witness God at work!

This past year has offered us some opportunities to witness God at work, not only through trials but also through encouraging reports. As I read the parochial reports I read of growth in some of our assemblies as well as improvements on the physical properties of our congregations. Regarding our mission works, we see that God has been at work in our three mission congregations. In Vermillion, God has brought students from China to the University of South Dakota. They have been attending our mission work there and are hearing the word of God preached. God only knows the impact that will have for the future of those students. In Greeley, Rev. Gene Sawtelle has labored faithfully, but has come to the point where he needs to retire from the pastorate. May God bless Rev. Sawtelle as he makes the transition and may God send the right man there to carry on the work of the gospel in that area. The Calhan congregation is also witnessing God at work as they work to establish a Reformed witness in that part of the world. And while we are on the subject of missions, perhaps it is time to think a little more proactively about missions in our classis. Two of our three current works are taking reductions in financial assistance and in a few years will be off completely. Where shall we go next for missions in the SSC? I believe we need to consider the larger cities within our boundaries. Omaha and Denver are a couple that come to mind.

Another ministry of the SSC is our Reformed Resource Center. This got it's impetus when Rev. Norman Hoeflinger's large theological library was donated to classis. Since that time it has been added to, especially various videos presentations given by different ministers of our denomination during youth camps or at retreats. The library has been moved from Lincoln to Vermillion and placed under the care of Heidelberg Theological Seminary where it has a much greater chance to be effectively used. During this classis meeting we need to decide what to do with the RRC. Should it be kept as its own separate entity or should it be given fully over to Heidelberg? May God give wisdom as we make this decision.

All in all we have been blessed by the Lord this past year. As it has been said, "God is there and He is not silent." May God continue his blessing in the coming year.

#### CONSTITUTIONAL QUESTIONS TO ELDERS (ARTICLE 81, RCUS ONSTITUTION)

- 5. *In providing for the furtherance of Christian stewardship:* 
  - a. Are the apportionments for the Classis paid according to the Guidelines for Giving? All Answered, "Yes."
  - b. Are these moneys sent promptly to the Classis treasurer? All answered, "Yes."
  - c. Are the apportionments for the Synod paid according to the Guideline for Giving? All answered, "Yes," except Earl Starks and Lon Ochsner who answered, "No."

- d. Are these moneys sent promptly to the Synod treasurer? All answered, "Yes," except Earl Starks who answered "no."
- 6. Are the church records properly kept? All answered, "Yes."

7a. Is the temporal contract between minister and people fulfilled in your charge? All answered, "Yes."

7b. Is the temporal contract between minister and people adequate to meet his temporal needs? All answered, "Yes."

# SPECIAL COMMITTEE REPORTS Heidelberg Youth Camp

A meeting of the Heidelberg Youth Camp Committee was held February 19, 2005. Committee members present were Elder Roger Gallimore, chair; Rev. Herman Van Stedum of the South Central Classis; and Rev. Mike McGee, Elder Tom Ochsner and Elder Chester Beck of the Northern Plains Classis. Rev. McGee opened in prayer. HYC 2005 will be held July 25-29 at Camp Bob Marshall in the Black Hills.

- 1. HYC 2004 evaluation results were reviewed. The following changes for HYC 2005 were made following this review:
  - □ The Monday night overview lesson was eliminated and instead will be conducted in cabin groups by the counselors. Plus, the first Heidelberg Youth Cup competition will begin following icebreakers.
  - ☐ The senior panel discussion will be changed such that questions and answers will be done in small groups.

- □ Due to the time and resources needed to adequately organize HYC, there will be a registration deadline of July 8. Registrations will not be taken after July 8.
- 2. The 2004 finance report was reviewed, which showed a net gain of \$894.02. The gain was a result of greater than expected enrollment last year and the large number of registration spaying the late fee.
- 3. The proposed 2005 budget was reviewed. The 2005 camper fees will again be \$125 per camper. However, if the registration and payment are received by June 10, the camper fee is \$113. The camp remains in good financial position, which is sufficient to cover expenses incurred prior to they start of camp. Please note that the cost of the committee meeting, video productions of the lessons and all the promotion are paid by HYC and not by the Classis.
- 4. The theme for HYC 2005 will be *Set Apart*. All lessons will center on how God's people are a holy nation and a royal priesthood in all of life. The following lessons will be given:
  - □ Male/Female Roles God created us male and female with very specific roles, responsibilities and abilities. This lesson reviews how God calls us we are to conduct ourselves according to our gender.
  - □ Getting Married Contemporary dating habits are simply not consistent with the Biblical worldview. This lesson describes how we are set apart in our process of finding a spouse.
  - □ The Church Young people are set apart in the body of believers. This lesson reviews how young people fit into the church and their responsibility to edify others in the body of Christ.
  - □ The Arts A look back in history would reveal that Christianity permeated the arts in nearly every way. This is not true today. This lesson examines the Christian perspective of art and what needs to be done to again influence the arts.
  - □ Our Conduct In a world full of profanity, trash-talking and selfish behavior, Christians should clearly stand out as being different. This lesson gives instruction on proper conduct and manners so that we will indeed be set apart.
  - □ Vocation (Seniors Only) How are we set apart in the workplace? This lesson examines the Biblical worldview of excellence in work.
  - □ Recreation (Juniors Only) In a society driven by the pursuit of recreation, how is the Christian set apart? This lesson puts recreation in its proper context.
  - In addition to the lessons, the following texts were agreed upon for the eveing worship services Genesis 1:28 (Tuesday), Romans 12:2 (Wednesday), 1 Peter 2:9 (Thursday).
- 5. Rev. McGee volunteered to recruit speakers for each of the lessons and worship services.
- 6. Elder Ochsner closed the meeting in prayer.

#### **Report of the Administrator of the Reformed Resource Center**

Rev. Howard Hart, Administrator February 20, 2006

Your servant submits the following report for this Classical year.

A. **ACTIVITIES**: Your servant was involved in the following activities this Classical year as Administrator of the RRC and TIM programs.

1/ The Hoeflinger Memorial Library is still available on floppy disks and should continue to function as a lending library. The discs are available to members of the denomination. The Library has been moved to Heidelberg Seminary. When the books have been placed in the seminary building your servant will inspect the library.

2/ The "Training in Ministry" program was implemented.

A/ An Internship program was submitted. Please note that this program was given to the Candidates and Credentials Committee for examination. I trust that we will continue to use this program.

B/ A Ministerial Retreat for the Midwest RCUS Ministers meeting at Mitchell, South Dakota was held on August 15-16, 2005. Twelve pastors met at Grace Reformed Church. Two Orthodox Presbyterian pastors attended.

Pastor Howard Hart lectured on "The Biblical Concept of Beauty."

Pastor Dale Clark lectured on "Modern Trends In Understanding Paul and Justification."

The lectures were well received and the pastors present remarked how helpful the lectures were. We are grateful for their time and energy.

C. The Administrator of the RRC and TIM programs is presenting a 20-page document on "Guidelines for Examination for Licensure and Ordination." I spent a number of hours on this task. I believe the Candidates and Credentials Committee is continuing to use and examine this document for possible use in the examination of candidates for our ministry. I have noted that some of the material has "popped-up" here and there in some of the Classical examinations the past few Classis meetings.

#### B. **VIDEOS**: The following videos are available:

1. "Apologetics - What We Think Before We Think" This is a four lecture course by Pastor R. Grossmann and Pastor H. Hart. Pastor Hart wrote a workbook to be used with the four lectures. Three copies of the originals are available to the churches and individuals. Pastor Grossmann's book on this subject is also available.

- 2. "Hermeneutics How To Study The Bible" by Pastor Hart. This is a five lecture series that shows people what the principles of Biblical interpretation are and how to use them. Pastor Hart produced a workbook to be used with the lectures.
- 3. "Theological Basis of confirmation and Catechetical Instruction" by Rev. R. Grossmann. This is an hour lecture. There is also an audiocassette available. This talk appears in a recent Reformed Herald.
- 4. "Reasons and Methodology of Catechetical Instruction" by Rev. H. E. Hart. This is an hour lecture that was given at a minister's retreat. There is a audiocassette available.
- 5. "The Seeker Sensitive Movement" by Rev. G. Horner. This is an hour lecture given at a minister's retreat. There is an audiocassette available.
- 6. "Studies in the Book of Daniel" by Pastor Hart. This is a twelve-lecture series video with a workbook.
- 7. "Kohlbrugge" by Rev. N Hoeflinger. This is a lecture given at an October 3, 1996 minister's retreat.
- 8. "A Conversation with Chester and Grace Ploeger.11 The Ploeger's reflect on their many years in the RCUS. (Taped February 18, 1997)
- 9. "Reformed Hermeneutics" by The Rev. Robert Grossmann. There are three lectures in this video which gives a Reformed perspective on our approach to Scripture.
- 10. "Homiletics" is a video study by the Rev. Howard E. Hart with David Fagrey that gives ministers of the Word a way to analyze their sermons. Pastor Hart gives the essential parts to a sermon and Pastor Fagrey, gives a sermon presentation that underlines this method of structuring sermons. There is another video on this topic from the seminar at New Geneva Seminary in 2000
- 11. "A Pastor's Approach to His Congregation Puritan/Covenantal" by the Rev George Syms. This lecture was delivered at the RCUS Ministerial Retreat in Watertown, SD September 6, 1999.
- 12. "Answering The Dilemmas Facing The Reformed In Bearing Witness" by the Rev. Jim Sawtelle. This is a lecture given at the RCUS Minister's Retreat in Watertown SD September 6, 1999.
- 13. "RCUS History" by the Rev Robert Grossmann and the Rev. Howard E. Hart. This 7-lecture video covers the history of our denomination in this country and surveys our routs in Germany. There is introductory material on why we are to study Church History by Pastor Hart. There is a second video made at New Geneva Seminary in 2000.
- 14. "Classis South Central of the RCUS opening Worship Service and Opening Session at Rock Springs, WY on October 11, 1999." This video has the Rev. C.W. Powell leading the worship service, and the Rev. Howard E. Hart preaching on John 1:14. The session of Classis South Central is opened by the Rev. Dorman Savage with the Rev. George Horner Stated Clerk. Some of the opening business is recorded.
- 15. "Lectures on Daniel" by the Rev. Howard E. Hart
- 16. "Hallowed Be Thy Names" a video on the Old Testament names of God. This is a 13-lecture presentation on the basic names of God by the Rev. Hart.
- 17. Lectures on the Constitution of the RCUS by Pastor Hart given at a seminar at New Geneva Seminary in 2000.
- 18. Lectures on the RCUS Directory of Worship by Pastor Savage made at Now Geneva Seminary in 2000.

- 19. "Definition of the Covenant" by Pastor Hart. A lecture that was given at the 2000 Minister's Retreat in Watertown, SD.
- 20. "The Covenant" A Lecture that was given by Pastor George Syms at the 2000 Minister's Retreat in Watertown, SD.
- 21. "The Covenant and the Canons of Dordt." A lecture given by Pastor Grossmann at the 2000 Minister's Retreat at Watertown, SD.
- 22. The 2001 Minister Conference given at Grace Reformed Church of Mitchell, SD. The tape contains devotions by the Rev. Darrel Kingswood on Romans 1,7,8; Dr. Warren Embree on "The Necessity and Content of Theological Education;" The Rev. Ron Morris on "How to Survive the Pastorate;" The Rev. David Dawn on "Surviving Church Discipline."
- 23. The 2002 Minister's Retreat given at Grace Reformed Church of Mitchell, SD. Reflecting Upon 50 years of Ministry" by OPC Minister Rev. G.I. Williamson. "War and the Muslim Holy War" by the Rev. Norman Jones. "Pastoring to the Local Community" by the Rev. Randy Klynsma.
- 24. The Winterum for Ministers and Elders of January 2003. "The Sin Against the Holy Spirit" by Howard Hart. "Comments on the Theology of Norman Shepherd" by Norman Jones.
- 25. From the 2003 Minister Retreat. "The Openness of God" by Professor C.W. Powell. "Instructing for Church Membership" by the Rev. Maynard Koerner.
- 26. From the 2004 Winterum for Ministers and Elders. "New Perspectives on Paul" by the Rev. Tracy Grugget. "God's Covenant and the Reformed Practice of Confirmation" by Dr. Robert Grossmann.

#### D. **FUTURE PLANS**:

I believe that the RRC should be dissolved.

Reasons: A. The long range plan of RRC was to eventually establish a Bible School or a Seminary of the RCUS. That goal has partially been met with the establishing of Seminaries in Sacramento and Vermillion.

- B. The above mentioned institutions are best suited for the Training in Ministry program of Classis South Central.
- C. Some of our churches and Heidelberg Seminary have been running very successful retreats for minister and office bearers. These may easily take the place of our retreats.
  - D. The RRC has not received requests for writing programs for the Classis and its committees.
  - E. Therefore, I believe that the RRC has served its usefulness over the past ten years and need not continue.

#### RECOMMENDATIONS

- 1/ That a curator for the Hoeflinger Memorial Library be given an honorarium of \$200.
- 2/ Take note that the treasurer of Classis be aware that Mrs. Hoeflinger is to receive a check of \$500.00 each January. Classis determined at the 2000 Spring Meeting to keep this yearly honorarium without a termination date.
- 3/ Take note that Pastor Hart has served as Administrator of the RRC and TIM for 10 years.
- 4/ That Classis continue to use the outline of the Internship Program.
- 5/ That Classis continue to use the "Guidelines for Examinations for Licensure and Ordination."
- 6/ That the RRC be dissolved.
- 7/ That South Central Classis' Permanent Committee on Christian Education have oversight of the Hoeflinger Memorial Library that is presently housed at Heidelberg Seminary.
- 8/ That the funds used for the operation of the RRC be taken off the Classical guidelines.

#### SPECIAL COMMITTEE TO INVESTIGATE MEMBERSHIP OF MINISTERS

The South Central Classis of the RCUS erected a committee to look into the issue of a minister's membership in the local congregation. Your committee has not conducted any formal meetings on this, but we have conversed about it on at least two occasions. One occasion was at the minister's winterim held in Mitchell, SD in January 2004. Providentially, Rev. G. I. Williamson of the Orthodox Presbyterian Church (OPC) was speaking at that meeting and we asked him about his opinion, as well as that of the OPC, and we are grateful for his thoughts regarding this issue.

The question is, where does a minister register his membership? Is he a member of a local congregation or is he only a member of classis? It has been the practice in certain quarters of the RCUS that a minister is only a member of classis. But what happens if, hypothetically, a minister's credentials are revoked by classis due to some act of discipline? Where does he now belong? This could be exacerbated if a minister who was deposed happened to remain in the same vicinity. It could happen that a local congregation holds the membership of a pastor's wife and children, but not the pastor. In this case, the consistory would have some amount of authority regarding the family, but not the former minister. He could miss church regularly and there is nothing the church can officially do; he is no longer a member anywhere.

The following issues should be taken into consideration:

- 1) Ministers, according to the constitution of the RCUS, are members of the "Church" which implies a member in good standing of a local congregation. (Art. 1, 27).
- 2) The Order of Dordt (1578) ruled that minsters were members of a local congregation and therefore could be a delegate to classis.
- 3) The voting members of classis are only members of classis because the local congregation delegated them, according to historic Reformed polity.
- 4) The Presbyterian form of government has the minister's credentials in the presbytery, but this does not prohibit his membership from being in a local congregation.

It may be helpful to view a minister's credentials and his membership in a local congregation as separate issues. Our recommendation is that ministers of the word should be members of a local congregation while keeping their ministerial credentials with the classis.

- 7. Take note with regard to overture 16.
- 8. Take note with regard to recommendation 4 from the report of the permanent candidates and credentials committee.
- 9. That when the Home Missions committee visits the Calhan congregation they include two members from the permanent Candidates and Credentials Committee.

Classis Action: Beside the take notes, all the recommendations and the report were adopted.

#### .Judicial

The committee brought the following recommendations:

#### STANDING RULES

- 1. Classical dues shall be due on the first of December and are to be paid not later than the Thirty-First of December of the current year (1960, '64, '68, '87).
- 2. The Parochial Reports and Statistics shall be forwarded two weeks before the Spring Meeting of Classis; the Parochial Reports to the President of the Executive Committee and the statistics to the Stated Clerk (1976, '77, '87).
- 3. The writ of certification for delegate elders for the Classical year shall be forwarded to the Stated Clerk two weeks before the Spring Meeting of Classis.
- 4. All congregations shall present an accurate report on confirmation instruction, Sunday School and weekday school. The period of instruction shall, if possible, be so extended that the pupils memorize and are able to recite the entire Catechism before confirmation. The course of instruction shall include Bible history, Catechism, Bible readings and the study of books and contents of the Bible; also singing, and preferably, Psalm-hymns.
- 5. The Standing Rules shall be read during the second session of the Spring Meeting (1932, '87).
- 6. If pastors, elders, and members of congregations request information from the Executive Committee of Classis concerning constitutional matters and procedures, as provided in Article 91, the answer shall, if the request is in order and in written form, be presented to the parties concerned only in written form and relevant only to the item in question (1933).
- 7. Delegate travel to Classis meetings shall be paid at the rate of twenty-two cents (.33) per running mile to each charge, if travel is by automobile. When distance and time require delegates to use public transportation to Classis, they shall be granted full fare (1965, '74, '80, '83, '94, 2006).
- 8. The Treasurer shall reimburse travel in behalf of Classis at twenty cents (.33) per running mile, also if several ride together in one car; or if by public transportation, the actual fare (1936, '54, '74, '80, '94, 2006).
- 9. Travel reimbursement shall be paid only those delegates to Classis whose congregations have paid the Classical dues in full to the Classis Treasurer, and those delegates who have attended all sessions of Classis or have been properly excused by Classis (1937, '67).
- 10. The President of the Executive Committee of Classis shall receive one hundred and fifty dollars (\$150.00), the Stated Clerk shall receive two hundred and fifty dollars (\$250.00), and the Treasurer shall receive one hundred and fifty dollars (\$150.00) for the Classical year (1960, '61, '65, '78, '84, '87, '90, 2003).

- 11. The monies sent to the Treasurer shall be made out in check form and designated for which fund and how much for each fund (1957).
- 12. The Executive Committee shall be authorized to advance the actual fare for public transportation to qualified candidates preaching trial sermons in our vacancies (1958, '87).
- 13. The Stated Clerk shall prepare for publication an abstract of the Classis minutes. The Spring Abstract shall include a cumulative index of resolutions and positions taken by Classis (1959, '87, '90).
- 14. The Classis shall have Permanent Committees as follows: Executive, Missions, Christian Education, Candidates and Credentials, Interchurch Relations, and Publications; and the Standing Committee of Nominations each year is to nominate men to serve on these committees (1961, '80, '85, '87, '91).
- 15. Nominations for all officers of Classis shall be made by secret ballot. All names appearing on the nominating ballot shall be candidates and, if there is no election on the first electing ballot, on each succeeding ballot the two candidates with the lowest number of votes shall be dropped until there is an election. (1962, '80, '87, '88).
- 16. Every charge that will not have an elder delegate at the Spring Meeting of Classis shall, before the date of the meeting, send in the answers to the questions placed before the elders according to Article 81 of the constitution. This copy shall be signed by all the elders of the charge and sent to the Stated Clerk (1963, '87).
- 17. The reports and recommendations of the Permanent and Special Committees of Classis shall be completed and mailed to all the Consistories of all the churches, with two copies to be sent to the Stated Clerk, four weeks prior to the meeting of Classis to which these reports and recommendations are to be presented. Excuses for this requirement are to be made only on written request to the Executive Committee of Classis by the chairman of the committee involved, at least two weeks before the meeting of Classis (1963, '70, '79, '82, '87,'90).
- 18. The services of Classis shall be prepared by the Executive Committee and these proposed services shall be circularized before Classis (1966, '72).
- 19. Students that are under the care of Classis shall be urged to attend only such seminaries approved by Classis. Only students who attend approved institutions shall be eligible for student aid while preparing for the Christian Ministry (1978, '87).
- 20. Classis shall require candidates for the ministry to complete an eight-month internship before his ordination exam. The internship shall be spent with a pastor who has served at least 5 years in the RCUS. The pastor shall provide a written evaluation of the candidate to the Candidates and Credentials committee. During this internship particular emphasis shall be placed on learning the peculiarities and practices of the RCUS. This internship requirement may be fulfilled either before or after the candidate has received a call or is licensed (1979, '87, '95).

- 21. Overtures sent to the Stated Clerk of Classis four weeks in advance of the Classis meeting shall be circularized, but overtures may be submitted to Classis at anytime (1986, '87).
- 22. The Spring Meeting of Classis shall be held at least one month before the annual meeting of Synod and shall start the 4<sup>th</sup> Tuesday of March opening with a worship service at 7:00 p.m., but if the 4<sup>th</sup> Tuesday is in the week before Easter, Classis shall meet the 3<sup>rd</sup> Tuesday of March. (1987, 2001, 2002).
- 23. Members of Classis submitting reports, overtures, and correspondence to Classis which will either be circularized or printed in Classis Minutes and Abstracts and which express personal opinions potentially offensive or slanderous against another brother or sister or to other members of Classis, shall govern themselves by I Peter 4:8 (1991).
- 24. All requests for reimbursement of expenses be made on the standard reimbursement form. Letters of explanation may be appended but do not substitute for reimbursement forms. Receipts must be attached (1997).

## (Spring 1986, Abstract p. 110)

The body voted "South Central Classis" as the official name for Classis.

# (Spring 1987, Abstract p. 5)

The following guidelines were adopted by Classis for delegates from the Classis to corresponding bodies:

- 1. ATTENDANCE: Be present at as many of the sessions as possible, register arrival with the Stated Clerk, hold private conversations with as many delegates as possible, and try to establish good relations between the Classis and the church which is being visited.
- 2. PREPARATION: Request reports, agendas, etc. from the Church which is being visited, be prepared to address actions taken by Classis or Synod, and take the current Abstract.
- 3. ADDRESSING THE BODY: Have a prepared address to present, seek to commend the body in the spirit of Philippians 4:8, inform the body of significant developments in the Classis and Synod, keep personal remarks to a minimum, and make clear which remarks are personal, and try to avoid negative criticisms. If a rebuke is needed refer the matter to the Interchurch Relations Committee.
- 4. STANDING COMMITTEES: Attend as many Standing Committee meetings as possible.
- 5. DECISIONS: Get as many copies of reports as possible and report any significant actions taken by the body.
- 6. REPORT: The report is to be sent to the Interchurch Relations Committee within one month of the meeting and is to include all actions taken by the body as well as any comments which the delegate thinks would be helpful to the Committee and Classis.
- 7. EXPENSES: Travel expenses are to be paid by the Classis and should be submitted to the Interchurch Relations Committee and the Classis Treasurer.

# (Fall 1987, Abstract p. 5)

That all reports from the Permanent Committee's be on 8 1/2" by 11" paper in order to better fit the Minutes.

# (Fall 1987, Abstract p.9)

That as soon as it is conveniently possible after each meeting of the South Central Classis, the Clerk of Classis send an Abstract of the Classis minutes to each Classis delegate. This Abstract does not have to be in a formally published form.

# (Spring 1988, Abstract p. 23)

The Classis does not see any theological problem with using one or many cups for communion; in light of the uncertainties concerning the transmission of AIDS, it may be advisable to use individual cups.

## (Spring 1989, Abstract p. 25)

That the Classis use a double entry ledger for Classis records.

## (Spring 1989, Abstract pp. 27-28)

The following procedures be used in calling an organizing pastor to a new mission work:

- a. The Consistory overseeing the mission work shall select a pastoral candidate in consultation with the members of the mission work and the Classis Home Missions Committee.
- b. The members of the proposed mission work, under the supervision of the Consistory, shall vote on calling the candidate.
- c. The Consistory shall extend the call.
- d. The organizing pastor shall work under the oversight of the Consistory as long as the work is unorganized.
- e. The mission work shall be under the oversight of the Classis Home Missions Committee as long as it has the status of a Mission Church.

## (Spring 1990, Abstract p. 27)

That all congregations - new and old - should see themselves as actively involved in the whole ministry of the church and should strive to meet the annual guidelines for giving.

# (Spring 1991, Abstract p. 20)

That a congregation requiring voting members to sign the constitution of a local congregation is not contradictory with the Constitution of the RCUS or Scripture.

# (Spring 1991, Abstract p. 21)

That the Permanent Home Missions Committee of Classis and the Permanent Foreign Missions Committee of Classis be combined into one Permanent Missions Committee, allowing either interest to be addressed by Classis.

# (Fall 1991, Abstract p. 22)

That no official stance be taken on the matter of fundraising.

That no constitutional impediment is found regarding using the word "Presbyterian" in the name of one of our churches.

# (Spring 1992, Abstract p. 41)

All bills submitted to the Treasurer must be signed by the one submitting the bill.

The Treasurer should inform the Finance Committee of those churches that have failed to pay their Classical dues.

# (Spring 1997, Abstract p. 33)

That the position papers of the Reformed Church in the United States be declared to be pastoral and advisory, giving the present consensus of the RCUS regarding the teaching of Scripture, and are of lesser authority than the Three Forms of Unity and the Constitution. Recommendations which make judicial decisions in connection with such papers are binding.
