PRESENTATION OF PERMANENT COMMITTEE REPORTS

Executive Committee (Referred to Overtures)

Executive Circulars Volume 23, Numbers 1-9

Number 1

May 10, 2008

Esteemed Fathers and Brothers:

There are two items that need your attention.

A. The executive committee received the following report, dated May 8, 2008, from the special committee to investigate whether charges are warranted as a response to a complaint:

Esteemed Brethren:

At the 2008 Spring Classis meeting held at Grace Reformed Church, Rapid City, South Dakota the South Central Classis erected a special committee in response to a complaint received from a member of the Blue Cliff congregation. The mandate given to the committee was to "investigate whether charges are warranted".

Classis appointed the following to this committee: Rev. Maynard Koerner, chairman, Rev. Warren Embree, Rev. Jon Blair, Elder David McPherson, Elder Spencer Gross and Elder Daniel Metter, with Rev. Scott Henry and Elder Gary Maassen as alternates.

The committee attempted to fulfill its mandate as quickly as possible. There were difficulties scheduling a trip to Colorado due to inclement weather, illness, and scheduling conflicts. On May 5 and 6, 2008 the committee met at Limon, CO. The committee which actually traveled and met with the members of the two congregations was composed of the following: Rev. Maynard Koerner, chairman, Rev. Jon Blair, Rev. Scott Henry, Elder Daniel Metter, and Elder Gary Maassen.

The committee determined to make itself available to all of the members of the joint charge of Blue Cliff RCUS and Providence RCUS of Limon. The committee met on Monday, May 5 from 1:00 pm until 10:00 pm and again on Tuesday, May 6 from 10:00 am until 6:30 pm. The committee first met with the Spiritual Council and gave an opportunity to answer the complaint. The committee then met individually with all of the member families, with one or two exceptions, as well as some interested friends of the congregation. The committee also received some written statements from members who were not able to be present, primarily college students. The committee also met at length with Pastor Matthew Powell. The committee concluded by meeting with the Spiritual Council a second time and presented its findings.

As a result of this investigation your committee presents the following recommendations:

1. We recommend that charges are not warranted.

Grounds:

A. Relative to specific doctrinal concerns raised, the committee found the doctrinal position of Rev. Matthew Powell to be in accord with the Scriptures as summarized in the Three Forms of Unity.

- B. The committee found that there was not sufficient basis to support the accusations in the complaint with respect to Rev. Matthew Powell's pastoral relationship with the congregation.
- 2. We recommend that this report be circularized.

B. The executive committee received a letter from the stated clerk of the Presbytery of the Dakotas, indicating that the Presbytery of the Dakotas is willing to receive High Plains Reformed Church in Calhan, CO as a congregation of the Orthodox Presbyterian Church, and therefore requests a letter of dismission from our Classis in accordance with our decision at our Spring Classis meeting (March 25-26, 2008), "That High Plains RCUS, Calhan, CO be dismissed to the Presbytery of the Dakotas OPC and that upon reception by the OPC the church be removed from the roll of churches of Classis." In accordance with our decision to dismiss the church at Calhan, the executive committee will send a letter of dismission to the Presbytery of the Dakotas. The letter on behalf of the Presbytery of the Dakota's reads in part:

"We regret that the Calhan church has chosen to leave the RCUS and wish they could have remained. We desire to be co-workers with you in the kingdom of our Lord Jesus Christ and pray that He will be glorified in the church at Calhan as well as in the RCUS and the OPC. Please continue to pray for us and for the church in Calhan that it will be a faithful witness to the truth of God in a sinful world. We are indebted to you for all that you have put into that congregation and will seek to be faithful stewards of His resources. We remember you in our prayers and rejoice in our fellowship in the gospel. We pray that brotherly love, peace, purity, and unity may increase among us all."

RECOMMENDATION: That the South Central Classis concur with the recommendations of the special committee's report to investigate whether charges are warranted.

MISSIONS

(Referred to Standing Missions)

Greeley, CO

On February 25th, 2009 Rev. C.W. Powell, Rev. Dan Rogers and Elder Loren Huber met with Rev. Jon Blair and his wife Wendy, the Consistory, and members of Grace RCUS. The meetings were conducted to allow for each group to share their perceptions on the direction and health of the church. Though each group saw things from their own perspective, what we found was a consistent report on the state of the church.

In general things are going well at Grace, the congregation is spiritually healthy, and stable. The marks of the church are present, the people are teachable, and there is a desire for spiritual growth. Rev. Blair mentioned that within in the congregation there is a "seriousness about the faith." All parties reaffirmed Rev. Blair's calling to the church in Greeley.

Recently the church has undergone a surge in attendance with a number of families now involved in membership classes. Most of these families home school their children and their presence has greatly increased the size of the Sunday school classes. The average attendance at Sunday worship is between 70 and 80.

The consistory has recognized the increased workload on Rev. Blair, mostly due to membership classes, and has worked to relieve him of other duties. Nine children are in catechism classes, with more on the horizon.

Financially the congregation is doing well and expects that 2010 will be their last year on mission support. The church's building debt has been reduced to \$28,000 and the consistory would like to thank the classis, synod, and churches that have helped them pay down this debt.

Overall our assessment of Grace RCUS is positive and we recommend that classis and synodical support continue.

Limon, CO

On February 19th, 2009, Rev. Dan Rogers and Elder Lon Ochsner visited with Rev. Matt Powell, members of the consistory, and lay people from Providence Reformed Church in Limon, Colorado.

Most members of South Central Classis are aware that 2008 was a difficult year for Providence. The result of the special fall classis meeting left many in the congregation upset and uncertain about what the Lord was doing. Yet as the book of Romans reminds us, "...we know that all things work together for good to those who love God, to those who are the called according to His purpose." (Romans 8:28)

According to Rev. Powell, Elder Ted Shieffelin, and Deacon Rick Carducci, God has used the events of the past year to unify and grow the church. They described how their church was "strengthened by the trials," "refreshed" by the changes, and brought "closer" in their fellowship. "*Oh, the depth of the riches both of the wisdom and knowledge of God! How unsearchable are His judgments and His ways past finding out!*" (Romans 11:33). Rev. Powell continues to work part-time (computer work) to supplement his income. Although the church receives support from classis, it is financially doing well, despite the departure of a number of members last year.

One change at the end of 2008 was the decision of the congregation of Blue Cliff Community RCUS in Karval, Colorado to dissolve their status as a separate church and transfer their members to Limon. Though this request still needs to be approved by classis, the addition of these members has been a blessing to both groups. Over the last few months the church has averaged about 50 for the Sunday morning worship service, sometimes even 60. In addition the church has had a number of regular visitors, the return of a family that moved from the area, and anticipates an adult baptism and profession of faith.

Overall, the assessment of Providence Reformed Church is encouraging and it is recommended that the church continue to be supported by South Central Classis. In addition, an overture has been forwarded to Classis to encourage the congregations of SCC to designate the offering of the 2009Day of Prayer for Missions for Providence's building debt of \$4,500.

Vermillion, SD

On March 4th, 2009, Elder Gary Maassen and Rev. Dan Rogers met in Vermillion, SD with Rev. Robert Grossmann, members of the Consistory, and members of the Providence Reformed Church congregation.

The first part of the meeting was a discussion with Rev. Grossmann concerning the overall well being of the church. According to Rev. Grossmann the work in Vermillion remains productive and encouraging, and many are "eager to learn." The worship, Sunday school, and Bible study times offered each week are well attended. Rev. Grossmann continues to be heard through a weekly radio message, broadcast throughout the region. Recently a family from Yankton began attending because of the broadcast.

The church continues to see steady but slow growth. Although the church is frequented by a number of college students from the University of South Dakota, the church has been blessed by the addition of a number of "solid families." One of the observations of a member of the consistory was that Rev. Grossmann "speaks to the people," which provides for learning but also good fellowship. Rev. Grossmann continues to teach at Heidelberg Theological Seminary, serve on various committees in the RCUS, and write articles for a number of publications.

The congregation continues to be active, growing, and generous. Giving was very good in 2008 and the church continues to cut back the amount of mission support they receive.

The Future of SCC Home Missions

It is the recognition of the SCC Home Missions Committee that it is the Lord who grows churches, though we plant, water and seek to sow the Word. This past year has yielded little in our hope to plant a church in either Denver, CO or Omaha, NE. Advertising in Omaha produced only a few telephone calls that did not lead to any other contacts. Since then, a number of members of the Home Missions Committee have conversed about the possibility of pursuing the old path – the path of sending a man to the prospective area. Not only would this be more of the Biblical model of church planting, it also would serve to answer the question we received most, "who do I contact in Omaha?"

In addition to Denver and Omaha, it has also been brought to our attention that both Casper and Gillette Wyoming are two of the fastest growing towns in the west. Casper is a city of 55,000 and Gillette a town of 30,000. Neither city has a Reformed or Presbyterian Church, although I was recently informed that there is a Bible study in Gillette which is considering the PCA. Like our church in Rock Springs, both communities are very dependent on the natural gas and mining industries.

Thus we are left with the following questions: do we pursue church planting only in reaction to outside interest or do we purposefully send men into cities to see what the Lord does? It seems that the Lord has blessed both approaches in the past, and so we should not limit ourselves to one or the other. Therefore it is the opinion of the SCC Home Missions Committee that we should set aside more money this year and in the years to come to explore both options.

Recommendations:

- 1. That Grace Reformed Church of Greeley, CO be given \$9,928.00 from SCC Home Missions for 2010.
- 2. That SCC overture Synod on behalf of Greeley for \$9,928.00 for 2010.
- 3. That Providence Reformed Church of Limon, CO be given \$9,000 from SCC Home Missions for 2010.
- 4. That Providence Reformed Church of Vermillion, SD be given \$5,000 from SCC Home Missions for 2010.
- 5. That SCC overture Synod on behalf of Vermillion for \$5,000 in 2010.
- 6. That SCC set aside \$20/Communicant member in 2010 for future Home Mission works.

CHRISTIAN EDUCATION

(Referred to Education and Student Aid)

Brethren,

At last years 'Spring Meeting' the Permanent Christian Education Committee was "mandated to study why many young people leave the RCUS, keeping in mind the concern expressed in the President's report on the state of the church" (Standing Overtures Committee, recommendation 13a, page 31 of the 2008 Abstract of the Minutes). With reference to the president's report, the concern expressed was "the continual seepage of people from many of our congregations."

Given this concern the president's report then focused on the role of demographics, ethnicity and theological (reformed) heritage with respect to cohesion and continuity within the RCUS in the past and

how this has changed in our present day. Young people are moving away from rural areas (demographics), drifting from their sense of ethnic identity (ethnicity) and "have been incorporated into the mainstream of American life." Along with these two trends the president's report identified a third and more troubling issue. And that issue His the fact that many of our young people are leaving behind their Reformed heritage."

As mentioned above your Permanent Christian Education Committee was given the mandate to study these matters. This is, of course, a very broad mandate. In the president's report it was suggested that we might study this matter by asking "each congregation to submit the names of those who have left our Church over the past, say, 10 years." We would then "contact these people and survey them. Find out, in a non-threatening way, why they left the Church. Once we can answer the question of why they are leaving, perhaps we can address the reason that they are leaving."

That, in a nut shell, was the mandate given to the committee. We did not formally meet as a committee. But as chairman I have had a number of discussions with several of the committee members with respect to the matter before us. As a result of these discussions we have tried to think through the "concern expressed in the President's report on the state of the Church" and believe that if we are to study this matter carefully we must focus our attention on what the president refers to as "the mainstream of American life" and how the cultural pressures of our day influence and shape the way many people view the whole question of theological conviction and their theological heritage. These two issues are inseparably related.

And thus, it would be very beneficial if we as leaders of the church had a better understanding of the cultural influence and power of what is being referred to in our day as "post modern thought." The "mainstream of American life" is dominated by the 'postmodern' worldview and as a result our young people are facing the forces and pressures of post modern thought and how all this relates to their theological/ reformed heritage. As we face this reality there are no quick fixes or easy answers.

The mandate given to this committee is entirely appropriate. We need to study. We need to take seriously our calling to bring "every thought into captivity to the obedience of Christ" as we "cast down arguments and every high thing that exalts itself against the knowledge of God" (2 Corinthians 10:5). In this way, we will be better equipped to help those who are in many ways unwittingly exposed to the pressures of postmodern thought in mainstream American life.

To help us in this study there are a number of books that we may find useful. As a committee, as we have endeavored to study this matter before us, we have found the following titles to be particularly relevant to the matter at hand:

- "No Place For Truth: Or Whatever Happened to Evangelical Theology?" (1993)
- "God In The Wasteland: The Reality of Truth in a World of Fading Dreams" (1994)
- "Losing Our Virtue: Why The Church Must Recover Its Moral Vision" (1999)
- "Above All Earthly Pow'rs: Christ in a Postmodern World" (2005)
- "The Courage To Be Protestant: Truth-lovers, Marketers, and Emergents in the Postmodern World" (all of the above are written by David F. Wells)
- "Christ & Culture Revisited" (2008)
- "Becoming Conversant With The Emerging Church: Understanding a Movement and Its Implications" (2005)
- The Gagging of God: Christianity Confronts Pluralism" (1996) (all of the above are written by D.A. Carson)

As is evident, this is a preliminary committee report. This whole matter requires further serious and indepth study. Your committee looks to the wisdom and guidance of Classis as to how we are to proceed in our study.

REPORTS OF OFFICERS President's Report on the State of the Church

Beloved in the Lord, grace to you and peace from God our Father and the Lord Jesus Christ. In Psalm 133 we read, "Behold, how good and how pleasant it is for brethren to dwell together in unity! It is like the precious oil upon the head, running down on the beard, the beard of Aaron, running down on the edge of his garments. It is like the dew of Hermon, descending upon the mountains of Zion; for there the LORD commanded the blessing — life forevermore." John Calvin, commenting on this passage, says that David is praising God for a time of peace and unity following a time of division in the nation of Israel. Calvin writes, "The hand of God was wonderfully seen, and most unexpectedly, in the concord which ensued among them, when these who had been inflamed with the most violent antipathy cordially coalesced."

It is a good thing when we can experience unity. But unity is not something that simply happens. It is something for which we must work. As Christians we sometimes have to determine to love our brothers and sisters in Christ, even if we vehemently disagree with them regarding some matter.

This is not some idea or concept in the abstract. It is something that we as Christians face every day. We have had some division in our Classis in the past. We have had our disagreements. But in the midst of our disagreements, I would like to believe that we have maintained a love for each other. This is not because we are such good people; it is because God is a gracious and merciful God. He deserves all the credit for any unity we have today and any unity that we will have in the future. Nevertheless, we must labor for this unity and always determine to love one another.

With this in mind, I would like to address a few issues. First of all, email. I both love and loath email. I love it because with the push of a button a communication can be sent to dozens, if not hundreds, of people. I also loath email because with a push of a button a communication can be sent to dozens, if

not hundreds, of people. In other words, sometimes an email can be misread, misunderstood and misinterpreted. Nuances, figures of speech, or tongue-in-cheek phrases can be misconstrued and can even bring offense. For this reason we need to be very careful with what we say and how we say things on email. I am thankful for electronic communication; it makes the job of communicating news to our congregations or things such as denominational committee work much easier. However, like any tool, it can cause damage if not used wisely.

Another thing I would like to address in the spirit of unity is the situation with many of our young people. In my President's Report last year I mentioned the "continual seepage of many of our young people from our congregations." This matter was taken up by Classis and a Special Committee was erected to look into this situation. That Committee will report to this Classis meeting with some recommendations. Without getting into that report, I would like to broach one particular issue that is not in the Committee's report: the role of fathers in the lives of our children. I want to be very clear here. I am not saying that if a young person grows up in our denomination and then leaves, it is because he or she had a dysfunctional father. There are many reasons why a young person may leave and the Committee's report will point out some of these things. What I am saying is that there is no way God will bless us as a Church if our fathers don't perform their roles as spiritual leaders of their families. This situation is not unique to the RCUS. Many men from a variety of denominational backgrounds have neglected their roles as spiritual leaders. This is why movements such as Promise Keepers became popular a few years ago. It addressed a deficiency and a need in the Church of Jesus Christ. Promise Keepers had its problems and I don't mean to be endorsing it. However, maybe we need a Promise Keepers-like movement in our Church today. Perhaps we need a summit or a Men's Retreat where the men of the RCUS could meet for a time of mutual encouragement and biblical instruction; a time of encouragement to our men to be godly husbands and fathers and to "step to the plate" and be the men God has called them to be. Don't misunderstand me. I'm not saying that we don't have godly men in our Church; we do. But this is an area where we need continual encouragement lest we drift away from our roles as spiritual leaders in the home.

On another note, it is with some sadness that we acknowledge the closing of one of our congregations at Blue Cliff, Colorado. The congregation at Blue Cliff worshiped there for some 30 years and served as a home base for our Regional Home Missionary, Dorman Savage. Blue Cliff helped oversee other mission works in Colorado and in contributed in an important way to much of the continuing work in Colorado. We are thankful that the entire congregation has voted to merge with our congregation in Limon as they preach the gospel to that community.

Speaking of preaching the gospel, we are at a time when we have a pastor shortage in the RCUS. As ministers and elders in the RCUS, we should make it our goal to help find prospective pastors from our own ranks. If you know of a young man who you believe may have the gifts to be a pastor, talk to him and encourage him to consider the ministry. Who knows, you may have your replacement sitting in the pew of your congregation!

In conclusion, having read the various Parochial Reports and getting a sense of what is happening in our congregations, I see that there is growth. This growth is not always measured numerically nor is it easy growth. Real, Christian growth is often gained spiritually through trials and temptations, victories and even defeats. But, most of all, growth is gained through the faithful preaching of the Word. Something that I can say without fear of contradiction is that if you hear a sermon from a minister of the RCUS, you are hearing a sermon from someone who believes that the Bible is the very Word of God and should be respected and adored. It is through the preaching of the Word that the people of God are strengthened and nurtured. Always be faithful to the preaching of God's holy, infallible Word and may we long to hear those words at the end of the day, "Well done, good and faithful servant."

Heidelberg Youth Camp Report February 16, 2009

A meeting of the Heidelberg Youth Camp Committee was held February 16, 2009. Committee members present were Elder Roger Gallimore, chair; Rev. Matt Powell and Rev. Scott Henry and Rev. Mike McGee, Rev. Richard Stetler, Elder Ron Abbink and Elder Jon Bender of Northern Plains Classis. Rev. McGee opened in prayer. HYC 2009 will be held July 20-24 at Camp Bob Marshall in the Black Hills.

1. The 2008 finance report was reviewed, which showed a net gain of \$13.53. The camp account remains in good shape with a balance of \$3,494.77. Camp fees will increase to \$139 per camper. It was pointed out that even with this increase; HYC continues to be an overwhelming bargain. Camper registrations and fees received after June 1 will be \$159. - 3. The theme for HYC 2009 will be *Our Reborn Identity*. This theme recognizes the need to kill off the old man of sin, bringing to life the new man in Christ, our role as prophet, priest and king and our need for lifelong training as Christians. The following lesson topics will be given:
 - Seeking and Speaking the Truth
 - Laying Yourself on the Line
 - Fighting the Battle
 - The Old Identity
 - The New Identity
 - Lifelong Training Camp
- 4. Rev. Scott Henry volunteered to recruit speakers for each of the lessons and worship services. Those that had volunteered to take on tasks are reminded of their duties for 2009:

NECROLOGIES

Clifford E. Mettler

Clifford E. Mettler was born on June 26, 1925 a few miles northeast of Menno, SD. He was baptized as an infant, and 14 years later he was confirmed by Rev. Bodenman at Zion Reformed Church, Menno, SD. Clifford remained a life long member of Zion RCUS where he faithfully served in the office of elder. Clifford passed away on Thursday, June 19, 2008 at Sacred Heart Hospital, Yankton, SD. He was one week shy of his 83rd birthday at the time of his death.

Edor K. Streyle

Edor K. Streyle was born August 7, 1910 on the family farm near Menno, SD. He was baptized on October 23, 1910, and was confirmed on June 7, 1925 by Rev. William Buetell at Zion Reformed Church, Menno, SD. Edor remained a life long member of Zion Reformed Church serving in the office of both deacon and elder. During his term as an elder, Edor often read a sermon on Sunday morning in the absence of Rev. William Korn, who was preaching at one of the other two churches he served along with Zion Reformed Church. Edor passed into glory on December 29, 2008, where he now rests from his labors.

STANDING RULES

- 1. Classical dues shall be due on the first of December and are to be paid not later than the Thirty-First of December of the current year (1960, '64, '68, '87).
- 2. The Parochial Reports and Statistics shall be forwarded two weeks before the Spring Meeting of Classis; the Parochial Reports to the President of the Executive Committee and the statistics to the Stated Clerk (1976, '77, '87).
- 3. The writ of certification for delegate elders for the Classical year shall be forwarded to the Stated Clerk two weeks before the Spring Meeting of Classis.
- 4. All congregations shall present an accurate report on confirmation instruction, Sunday School and weekday school. The period of instruction shall, if possible, be so extended that the pupils memorize and are able to recite the entire Catechism before confirmation. The course of instruction shall include Bible history, Catechism, Bible readings and the study of books and contents of the Bible; also singing, and preferably, Psalm-hymns.
- 5. The Standing Rules shall be read during the second session of the Spring Meeting (1932, '87).

- 6. If pastors, elders, and members of congregations request information from the Executive Committee of Classis concerning constitutional matters and procedures, as provided in Article 91, the answer shall, if the request is in order and in written form, be presented to the parties concerned only in written form and relevant only to the item in question (1933).
- 7. Delegate travel to Classis meetings shall be paid at the rate of thirty-three cents (.33) per running mile to each charge, if travel is by automobile. When distance and time require delegates to use public transportation to Classis, they shall be granted full fare (1965, '74, '80, '83, '94, 2006).
- 8. The Treasurer shall reimburse travel in behalf of Classis at thirty-three cents (.33) per running mile, also if several ride together in one car; or if by public transportation, the actual fare (1936, '54, '74, '80, '94, 2006).
- 9. Travel reimbursement shall be paid only those delegates to Classis whose congregations have paid the Classical dues in full to the Classis Treasurer, and those delegates who have attended all sessions of Classis or have been properly excused by Classis (1937, '67).
- 10. The President of the Executive Committee of Classis shall receive one hundred and fifty dollars (\$150.00), the Stated Clerk shall receive two hundred and fifty dollars (\$250.00), and the Treasurer shall receive one hundred and fifty dollars (\$150.00) for the Classical year (1960, '61, '65, '78, '84, '87, '90, 2003).
- 11. The monies sent to the Treasurer shall be made out in check form and designated for which fund and how much for each fund (1957).
- 12. The Executive Committee shall be authorized to advance the actual fare for public transportation to qualified candidates preaching trial sermons in our vacancies (1958, '87).
- 13. The Stated Clerk shall prepare for publication an abstract of the Classis minutes. The Spring Abstract shall include a cumulative index of resolutions and positions taken by Classis (1959, '87, '90).
- 14. The Classis shall have Permanent Committees as follows: Executive, Missions, Christian Education, Candidates and Credentials, Interchurch Relations, and Publications; and the Standing Committee of Nominations each year is to nominate men to serve on these committees (1961, '80, '85, '87, '91).
- 15. Nominations for all officers of Classis shall be made by secret ballot. All names appearing on the nominating ballot shall be candidates and, if there is no election on the first electing ballot, on each succeeding ballot the two candidates with the lowest number of votes shall be dropped until there is an election. (1962, '80, '87, '88).
- 16. Every charge that will not have an elder delegate at the Spring Meeting of Classis shall, before the date of the meeting, send in the answers to the questions placed before the elders according to Article 81 of the constitution. This copy shall be signed by all the elders of the charge and sent to the Stated Clerk (1963, '87).

- 17. The reports and recommendations of the Permanent and Special Committees of Classis shall be completed and mailed to all the Consistories of all the churches, with two copies to be sent to the Stated Clerk, four weeks prior to the meeting of Classis to which these reports and recommendations are to be presented. Excuses for this requirement are to be made only on written request to the Executive Committee of Classis by the chairman of the committee involved, at least two weeks before the meeting of Classis (1963, '70, '79, '82, '87, '90).
- 18. The services of Classis shall be prepared by the Executive Committee and these proposed services shall be circularized before Classis (1966, '72).
- 19. Students that are under the care of Classis shall be urged to attend only such seminaries approved by Classis. Only students who attend approved institutions shall be eligible for student aid while preparing for the Christian Ministry (1978, '87).
- 20. Classis shall require candidates for the ministry to complete an eight-month internship before his ordination exam. The internship shall be spent with a pastor who has served at least 5 years in the RCUS. The pastor shall provide a written evaluation of the candidate to the Candidates and Credentials committee. During this internship particular emphasis shall be placed on learning the peculiarities and practices of the RCUS. This internship requirement may be fulfilled either before or after the candidate has received a call or is licensed (1979, '87, '95).
- 21. Overtures sent to the Stated Clerk of Classis four weeks in advance of the Classis meeting shall be circularized, but overtures may be submitted to Classis at anytime (1986, '87).
- 22. The Spring Meeting of Classis shall be held at least one month before the annual meeting of Synod and shall start the 4th Monday of March opening with a worship service at 7:00 p.m., but if the 4th Monday is in the week before Easter, Classis shall meet the 3rd Monday of March (1987, 2001, 2002, 2009).
- 23. Members of Classis submitting reports, overtures, and correspondence to Classis which will either be circularized or printed in Classis Minutes and Abstracts and which express personal opinions potentially offensive or slanderous against another brother or sister or to other members of Classis, shall govern themselves by I Peter 4:8 (1991).
- 24. All requests for reimbursement of expenses be made on the standard reimbursement form. Letters of explanation may be appended but do not substitute for reimbursement forms. Receipts must be attached (1997).

INDEX OF RESOLUTIONS AND POSITIONS

(Spring 1986, Abstract p. 110)

The body voted "South Central Classis" as the official name for Classis.

(Spring 1987, Abstract p. 5)

The following guidelines were adopted by Classis for delegates from the Classis to corresponding bodies:

- 1. ATTENDANCE: Be present at as many of the sessions as possible, register arrival with the Stated Clerk, hold private conversations with as many delegates as possible, and try to establish good relations between the Classis and the church which is being visited.
- 2. PREPARATION: Request reports, agendas, etc. from the Church which is being visited, be prepared to address actions taken by Classis or Synod, and take the current Abstract.
- 3. ADDRESSING THE BODY: Have a prepared address to present, seek to commend the body in the spirit of Philippians 4:8, inform the body of significant developments in the Classis and Synod, keep personal remarks to a minimum, and make clear which remarks are personal, and try to avoid negative criticisms. If a rebuke is needed refer the matter to the Interchurch Relations Committee.
- 4. STANDING COMMITTEES: Attend as many Standing Committee meetings as possible.
- 5. DECISIONS: Get as many copies of reports as possible and report any significant actions taken by the body.
- 6. REPORT: The report is to be sent to the Interchurch Relations Committee within one month of the meeting and is to include all actions taken by the body as well as any comments which the delegate thinks would be helpful to the Committee and Classis.
- 7. EXPENSES: Travel expenses are to be paid by the Classis and should be submitted to the Interchurch Relations Committee and the Classis Treasurer.

(Fall 1987, Abstract p. 5)

That all reports from the Permanent Committee's be on 8 1/2" by 11" paper in order to better fit the Minutes.

(Fall 1987, Abstract p.9)

That as soon as it is conveniently possible after each meeting of the South Central Classis, the Clerk of Classis send an Abstract of the Classis minutes to each Classis delegate. This Abstract does not have to be in a formally published form.

(Spring 1988, Abstract p. 23)

The Classis does not see any theological problem with using one or many cups for communion; in light of the uncertainties concerning the transmission of AIDS, it may be advisable to use individual cups.

(Spring 1989, Abstract p. 25)

That the Classis use a double entry ledger for Classis records.

(Spring 1989, Abstract pp. 27-28)

The following procedures be used in calling an organizing pastor to a new mission work:

- a. The Consistory overseeing the mission work shall select a pastoral candidate in consultation with the members of the mission work and the Classis Home Missions Committee.
- b. The members of the proposed mission work, under the supervision of the Consistory, shall vote on calling the candidate.
- c. The Consistory shall extend the call.
- d. The organizing pastor shall work under the oversight of the Consistory as long as the work is unorganized.
- e. The mission work shall be under the oversight of the Classis Home Missions Committee as long as it has the status of a Mission Church.

(Spring 1990, Abstract p. 27)

That all congregations - new and old - should see themselves as actively involved in the whole ministry of the church and should strive to meet the annual guidelines for giving.

(Spring 1991, Abstract p. 20)

That a congregation requiring voting members to sign the constitution of a local congregation is not contradictory with the Constitution of the RCUS or Scripture.

(Spring 1991, Abstract p. 21)

That the Permanent Home Missions Committee of Classis and the Permanent Foreign Missions Committee of Classis be combined into one Permanent Missions Committee, allowing either interest to be addressed by Classis.

(Fall 1991, Abstract p. 22)

That no official stance be taken on the matter of fundraising.

That no constitutional impediment is found regarding using the word "Presbyterian" in the name of one of our churches.

(Spring 1992, Abstract p. 41)

All bills submitted to the Treasurer must be signed by the one submitting the bill.

The Treasurer should inform the Finance Committee of those churches that have failed to pay their Classical dues.

(Spring 1997, Abstract p. 33)

That the position papers of the Reformed Church in the United States be declared to be pastoral and advisory, giving the present consensus of the RCUS regarding the teaching of Scripture, and are of lesser authority than the Three Forms of Unity and the Constitution. Recommendations which make judicial decisions in connection with such papers are binding.

(Spring 2007, Abstract)

That Classis nominations Committee regularly consider the workload borne by Classical delegates during the year and refrain from recommending that Executive Committee members be appointed as chairman of a permanent or special committee of Classis.

Minutes of the Sessions

I. Services.

The President, Rev. Ron Morris, called the body to order at 1:00 p.m. on October 14, 2008.

Rev. Dan Rogers read Psalm 133 and led the body in prayer.

II. Organization.

A. Roll Call

The Clerk, Rev. David Fagrey, read the roll. Opening Roll call showed 12 Ministers and 9 elders present. The President declared a quorum.

IV. The Calling Up of Complaints and Appeals

The Executive committee was appointed to examine the complaints and appeals against the Spiritual Council of Limon and Blue Cliff.

The Executive Committee recommends that the following items be considered regular and proper and that they be heard by Classis: a. The Complaint by Rev. Robert Grossmann on behalf of Mrs. Kay Savage against the Spiritual Council of Limon/Blue Cliff; b. The Complaint by Clinton and Kathy Clark against the Spiritual Council of Limon/Blue Cliff; c. The Appeal of Mrs. Kay Savage of the action taken against her by the Spiritual Council of Limon/Blue Cliff; d. The Appeal of Clinton and Kathy Clark of the action taken against them by the Spiritual Council of Limon/Blue Cliff; e. The Appeal of Lance and Paula Brundage of the action taken against them by the Spiritual Council of Limon/Blue Cliff.

The clerk read item #1a: the complaint of Rev. Grossmann.

Grossmann presented the appellant's opening statement.

Matt Powell presented the case of the Limon and Blue Cliff Spiritual Council.

Grossmann presented the appellant's closing statement.

Members of the body were given opportunity to be heard.

Elder Ted Schieffelin read the Spiritual Council minutes pertaining to this case.

Morris called for a roll call vote on item #1a, Specification 1: "Did the Limon and Blue Cliff Spiritual Council wrongly deny a request for transfer of Mrs. Kay Savage to the Orthodox Presbyterian Church in Calhan, CO?"

The clerk called the roll, which showed 17 Yes and 2 No. The complaint of Rev. Grossmann was sustained.

Rev. Warren Embree moved to table the final disposition of Grossmann's complaint until after the body hears the appeal of Mrs. Kay Savage. Seconded and carried.

The clerk read item #1b: the complaint of Clinton and Cathleen Clark.

Jim Sawtelle presented the appellant's opening statement.

Matt Powell presented the case of the Limon and Blue Cliff Spiritual Council.

Sawtelle presented the appellant's closing statement.

Members of the body were given opportunity to be heard.

Bud Powell moved to proceed to a roll call vote on item #1b. Seconded and carried.

The clerk called the roll for Specification 1: "Did the Limon and Blue Cliff Spiritual Council wrongly deny a request for transfer of Clinton and Cathleen Clark to the Orthodox Presbyterian Church in Calhan, CO?"

The vote showed 20 Yes and 0 No. The specification was sustained.

The clerk called the roll for specification 2: "Did the Limon and Blue Cliff Spiritual Council overstep their constitutional responsibilities in the handling of the Clarks' request of transfer?"

The vote showed 13 Yes, 4 No, and 3 Present. The Specification was sustained.

Embree moved to table the final disposition of the Clarks' complaint until after the body hears the appeal from the Clarks. Seconded and carried.

The clerk read item #1c: the appeal from Mrs. Kay Savage.

Grossmann presented the appellant's opening statement.

The chair ruled a portion of Grossmann's presentation out of order.

Matt Powell presented the case of the Limon and Blue Cliff Spiritual Council.

Grossmann presented the appellant's closing statement.

Members of the body were given opportunity to be heard.

Koerner moved to proceed to a roll call vote on item #1c. Seconded and carried.

The clerk called the roll for Specification 1: "Was the decision of guilt unjust?"

The vote showed 14 Yes, 3 No, and 2 Present. Specification 1 was sustained.

The clerk called the roll for Specification 2: "Was the sentence of excommunication too harsh?" The vote showed 19 Yes, 0 No. Specification 2 was sustained.

Embree moved to table the final disposition of this appeal until tomorrow morning. Seconded and carried.

Morris called the order of the day at 9:10 p.m.

II. Organization. Wednesday, October 15, 2008.

Morris called the body to order at 8:00 a.m.

Rev. Darrell Kingswood opened with prayer.

a. Roll Call

The clerk read the roll. The roll showed 11 Ministers and 8 elders present. The President declared a quorum.

IV. The Calling Up of Complaints and Appeals

Embree moved to consider the disposition of both the complaint of Robert Grossmann and the appeal of Mrs. Kay Savage. Seconded and carried.

Koerner moved that Mrs. Kay Savage be censured for her untrue statements, and that her request for transfer to the Orthodox Presbyterian Church in Calhan, CO be granted; and that a communication be sent to the session in Calhan informing them of our action. Seconded and carried.

In accordance with article 169, the following errors were entered on the record: The Spiritual Council of Limon and Blue Cliff erred in not granting Mrs. Kay Savage her request for transfer. They also erred in their decision to find Mrs. Savage guilty of breaking the ninth commandment, not having sufficient evidence to prove the specific lies they charged her with. The Spiritual Council of Limon and Blue Cliff erred in their sentence of excommunication, in that it was too harsh.

The clerk read item #1d: the appeal of Clinton and Cathleen Clark.

Sawtelle presented the appellant's opening statement.

Matt Powell presented the case of the Limon and Blue Cliff Spiritual Council.

Sawtelle presented the appellant's closing statement.

Members of the body were given opportunity to be heard.

Grossmann moved to proceed to a roll call vote on item #1d. Seconded and carried.

Division was called. Division showed 10 Yes and 9 No. The chair was sustained.

The clerk called the roll for Specification 1: "Did the Limon and Blue Bliff Spiritual Council fail to substantiate the alleged charges against the Clarks?" The vote showed 10 Yes, 7 No, and 3 Present. Specification #1 was sustained.

The clerk called the roll for Specification 2: "Did the Limon and Blue Cliff Spiritual Council act in "undue haste" in charging the Clark's with rebelliousness?"

The vote showed 10 Yes, 8 No, and 2 Present. Specification 2 was sustained.

The clerk called the roll for Specification 3a: "Did the Limon and Blue Cliff Spiritual Council fail to demonstrate a reasonable indulgence?" The vote showed 5 Yes, 13 No, and 2 Present. Specification 3a was defeated.

The clerk called the roll for Specification 3b: "Did the Limon and Blue Cliff Spiritual Council demonstrate a manifest prejudice?"

The vote showed 1 Yes, 18 No, and 1 Present. Specification 3b was defeated.

Grossmann moved to handle the disposition of the Clarks' complaint and their appeal at the same time. Seconded and carried.

Grossmann moved to censure the Clarks for contumacy and that their request for transfer to the OPC church in Calhan, CO. be granted; and that a communication be sent to the session in Calhan informing them of our action. Seconded and carried.

In accordance with article 169, the following errors were entered on the record: The Limon and Blue cliff Spiritual Council erred in not granting the Clarks' request for transfer. They also failed to substantiate the alleged charges against the Clarks. Classis censured the Clarks for contumacy because they refused to show up to their trial to defend themselves against the alleged charges.

The clerk read item #1e: the appeal of Lance and Paula Brundage.

Embree presented the appellant's opening statement.

Matt Powell presented the case of the Limon and Blue Cliff Spiritual Council.

Embree presented the appellant's closing statement.

Members of the body were given opportunity to be heard.

The clerk called the roll for Specification 1: "Did the Limon and Blue Cliff Spiritual Council fail to follow the proper procedures of erasure according to Article 119?"

The vote showed 16 Yes, 1 No, and 1 Present. Specification 1 was sustained.

In accordance with article 169, the following errors were entered on the record: The Limon and Blue Cliff Spiritual Council erred in not following the proper procedures of erasure, according to Article 119. The Spiritual Council erred in making a non-judicial case into a judicial matter. Therefore, they erred in giving the Brundages a judicial erasure instead of an administrative erasure.

Koerner moved that members of the Brundage family be erased from the rolls of the Limon and Blue Cliff charge by administrative erasure. Seconded and carried.
